# 81.1 Approval of the agenda and of minutes of board meeting 80

#### 2. NOVA Strategy Seminar 2019

According to the NOVA Strategy for 2018-2021, there should be a NOVA strategy seminar each year. Participants are the board members, local coordinators, the Nordplus coordinator and the NOVA Student Board. Other experts and participants can be invited depending on the topic for the seminar. The purpose of the seminar is to "examine how well the goals have been attained, to prepare an activity plan for two years at a time when relevant, as well as to ensure that all the NOVA functions are focused on achieving the mission, vision and the goals defined in the strategy."

AU-ST has kindly agreed to host the NOVA Strategy Seminar 2019.

The Board wish that the following proposals for topics for the Strategy Seminar 2019 are incorporated:

- NOVA's future
  - Discussion regarding future core activities
  - o Role of the NOVA network
- Industrial cooperation and innovation
  - O How do the different member universities do this?
  - Potential for organising NOVA courses in collaboration with the industry in the light of innovation
- Interdisciplinary cooperation
  - o Cooperation across disciplines to meet UN's Sustainable Development Goals

The Board noted the information presented by the Secretariat.



# 3. External funding of NOVA courses

At board meeting 80 (resolution 80.3.5), the Board asked the Secretariat to present statistics on external funding reported to NOVA for courses that have been run during the last years.

The presented information is based on reporting from course leaders and calculation of amounts sent directly to NOVA from external partners (i.e. Nordplus, Nordic Forest Research (SNS), the Nordic Joint Committee for Agricultural and Food Research (NKJ)).

The presented figures give an impression of the situation, but they are not exact due to changes in the exchange rates and registered information based on five different currencies. In addition, a review of the replies from teachers shows that the registered information is not completely comparable.

Types of sources for reported external financing and corresponding costs:

- Financing from own institution e.g. for teachers' working hours and travels, student meals/dinners
- Financing from other sources like Erasmus+ e.g. for teachers' working hours and travels
- Funding from research networks/schools, doctoral programmes or other projects they are already involved in
- Self financing e.g. they have organised the course as extra work on top of their regular job

In addition, master's students have received support for travel and accommodation expenses from Nordplus when attending NOVA courses. This is not included in the tables below.

Since 2016, the course organisers keep 50% of the course fee on PhD courses. The rest is subtracted from the final payment from NOVA. In 2015, 100% of the fee was subtracted from the final payment from NOVA.

Short evaluation by the Secretariat:

Evaluating the registered external funding has proven difficult as the registered information is ambiguous.

The amount of reported external funding, not including funding from partners with which the NOVA Network has cooperation agreements, is low. However, financing from the NOVA member institutions of expenses related to NOVA teachers is probably higher than reported as it seems that teachers understand the question regarding external funding differently. For example, course leaders from AU-ST are reporting what they have received from their institution or their graduate school to cover costs for teaching/planning NOVA courses, whereas others do not register that. There is also uncertainty related to whether the financing of some of the funding sources such as research/doctoral schools or PhD programmes comes from NOVA institutions or not. This funding is thus categorised under "Reported funding from miscellaneous sources" in the tables below. Thus, the Secretariat is unsure of the value of the teachers' feedback and thinks that the scientific teams are strategic when reporting on external funding.

It is positive that two of the master's courses also received funding for the course from Nordplus directly. This corresponded to approximately 30% of NOVA's total payments to NOVA master's courses from 2015 to 2017.

#### 4. Verbal presentation by the Secretariat

# Contact with SNS

The Secretariat has negotiated a renewal of the agreement between NOVA and Nordic Forest Research (SNS) on funding of forestry related NOVA PhD courses for 2018-2019. By 29 November 2018, NOVA had received the funding from SNS for 2017.

#### Promotion of NOVA at the member institutions

The Board wished to receive a presentation to use when promoting NOVA to teachers and students at their universities. The presentation were to include some information on NOVA's history, cf. resolution 80.8.2. The Secretariat developed the presentation and send it to the Board and the local coordinators in August 2018.

# **Resolution:**

The Board noted the information presented by the Secretariat.

# 81.3 Evaluation and revison of regulations for NOVA courses and other projects

At board meeting 78, the Board approved new regulations for NOVA courses and other projects, which were valid from 1 Jan. 2018. At the *per capsulam* meeting in October 2018, the Board wished that the regulations regarding course fee on PhD courses were discussed at board meeting 81. Some courses had applied for an exemption from the course fee. The application process for course series was also discussed at the current meeting.

Some of the main arguments for not collecting course fee on NOVA PhD courses from other students than NOVA/BOVA students, were that it was perceived as unfair, that it could lead to more prospective students



on courses, that it could lead to increased motivation for teachers to run courses as well as increased course quality, and that some institutions/teachers did not collect the fee.

The main reasons for modifying the application process for course series were to improve the course quality and improve and reduce administration for teachers and other employees, as there had been challenges in that respect during the last years.

# **Resolution:**

The Board approved the changes below in NOVA's regulations.

# 1.5.2. Special regulations for PhD courses – applications submitted to NOVA before 1 January 2018 1.5.2.e.:

There is no course fee on NOVA PhD courses for NOVA and BOVA students. There is neither any course fee for non-NOVA and non-BOVA students, except that teachers/researchers and participants from the industry (i.e. participant categories: other non-PhD student and participants from the industry) can be charged a course fee. The course organiser must charge all participants that are non-NOVA and non-BOVA students for meals.

- The changes regarding course fee are valid for courses running after 1 Jan. 2019. However, the changes regarding course fee are optional for courses running in 2019.

# 1.5.3. Special regulations for PhD courses (including PhD activities and competence-enhancing courses) – applications submitted to NOVA after 1 January 2018 1.5.3.c.:

There is no course fee on NOVA PhD courses for NOVA and BOVA students. There is neither any course fee for non-NOVA and non-BOVA students, except that teachers/researchers and participants from the industry (i.e. participant categories: other non-PhD student and participants from the industry) can be charged a course fee.

- The changes regarding course fee are valid for courses running after 1 Jan. 2019. However, the changes regarding course fee are optional for courses running in 2019.

# 1.5.3.1. Special regulations for competence-enhancing courses 1.5.3.1.b.:

Scientists from NOVA and BOVA member institutions who are not PhD students are not regarded as NOVA or BOVA students. In accordance with § 1.5.3.c., such participants (i.e. participant categories: other non-PhD student, as well as participants from the industry) can be charged a course fee.

- The changes regarding course fee are valid for courses running after 1 Jan. 2019. However, the changes regarding course fee are optional for courses running in 2019.

# 1.6. Non-NOVA students

a. Students and others not registered at a NOVA member institution are welcome to take a course if space is available. Admission is handled by the course leader in accordance with local regulations. On NOVA PhD courses, there is no course fee for non-NOVA and non-BOVA students, except that teachers/researchers and participants from the industry (i.e. participant categories: other non-PhD student and participants from the



industry) can be charged a course fee, cf. §1.5.2.e. (course applications submitted before 1 Jan. 2018) or §1.5.3.c. (course applications submitted after 1 Jan. 2018).

- b. The NOVA members at Aarhus University, Science and Technology, are responsible for actively informing their students about their status as regards to NOVA.
- c. For PhD course applications submitted to NOVA before 1 January 2018, regulations on accommodation, meals and material costs for non-NOVA and non-BOVA students are detailed in §§1.5.2.d.b. and c., 1.5.2.e., and 1.5.2.f.
- d. For course applications submitted to NOVA after 1 January 2018, there are no special regulations on accommodation, meals and material costs for non-NOVA and non-BOVA students.
- The changes regarding course fee are valid for courses running after 1 Jan. 2019. However, the changes regarding course fee are optional for courses running in 2019.

# 1.4.4. Course series

NOVA UN supports series of courses offered yearly or every second year on PhD or master's level (maximum four courses in a series or two identical courses given every second year will be funded). The courses should preferably be offered by different member institutions each year. The courses can either be a series of courses within a related area, courses that form a thematic whole, or identical courses.

The respective applicant for the second to fourth course in the series must submit an application for his/her course for the board meeting in June the year before the course is scheduled to run. The Board will take student evaluations of previous courses in the series into consideration when reviewing applications for the second, third and fourth course in the series.

- The changes regarding course series are valid for applications for new course series submitted after 1 Jan. 2019.

# 81.4 Accounts by November 2018 and approval of budget 2019

Table 1 "Result and balance Nov. 2018" contains an overview of the accounts in the period 2014-2017. The accounts by the end of Oct. 2018 and the forecast for 2018 are presented next. The column "budget 2018" shows the revised budget for 2018 (resolution 80.3.3). Finally, the approved budget for 2019 is presented. Table 2 shows the member fee and the probable current future commitments for courses until 2022. Tables 3 and 4 contain the member fee percentages for 2018-2019 (resolution 77.4.4.) as well as the member fees in EUR.

- \*The course is part of the series Climate change entomology in the North:
- Course 3 (2019) was granted funding of maximum EUR 19 556 plus an incentive grant to be used on administration of EUR 2 500. The NOVA funding of the course will be dependent on the student evaluations of previous courses within the series, as well as the yearly NOVA course budget.
- \*\*The course is part of the series Environmental collaboration and conflict resolution:
- Course 4 (2019) was granted funding of maximum EUR 21 883 plus an incentive grant to be used on administration of EUR 2 500. The funding of a one-day's excursion, which is included in the maximum grant, is conditioned that the excursion takes place in the five-day's on-site course. The course title is changed to Explorations of Collaborative Closures in Environmental Conflicts. The course is granted an exemption from the NOVA course fee. This is a one-time exemption.
- \*\*\*The course is part of the course series Plant pathology with a Nordic dimension:
- Course 3 (2019) was granted funding of maximum EUR 17 122 plus an incentive grant to be used on administration of EUR 2 500.
- \*\*\*\*The course is part of the series Phenotyping technologies in plant-environment interactions:
- Course 2 (2019) was granted funding of maximum EUR 14 156 plus an incentive grant to be used on administration of EUR 2 500.
- \*\*\*\*\*The course is part of the course series Ecostacking: a new approach to crop protection. The course is granted the following funding:
- a total lump sum of €10,000, which is a flat rate, plus €1,000 to cover administration, and
- an incentive grant of €2,000 for course in field prioritised by the NOVA Board in the Open Call 2018.

# 81.6 Rotating secretariat - next chair

NMBU's period as chair of NOVA and host of the NOVA secretariat will end on 31 December 2019. NMBU will then have hosted the NOVA secretariat for the two last periods: i.e. from 2014 to 2016, and from 2017 to 2019. Discussions concerning the future host of the NOVA secretariat for 2020-2022 were initiated.

#### Resolution:

- 1. The decision on the host of the NOVA secretariat for 2020-2022 was postponed to board meeting 82.
- 2. The NOVA Chair will call for a meeting regarding the possibility of AU-ST hosting the NOVA secretariat in 2020-2022. The participants at the meeting will be the NOVA Chair and the NOVA board member from AU-ST, and possibly the deputy NOVA board member from AU-ST.

# 81.7 Cooperation with Indonesian university

This item was presented verbally at the meeting.

On October 17, 2018 the NOVA Secretariat received an email from Dr. Ingeborg Menzler-Hokkanen, Department of Agricultural Sciences, University of Helsinki.

The entomology group at HU-AF has entered into cooperation with UNHAS (Universitas Hasanuddin, Sulawesi, Makassar) in Indonesia, and would like to continue this cooperation further. Dr. Ingeborg Menzler-Hokkanen argues that UNHAS and the region need help and encouragement after the large earthquake struck on September 28, 2018 and killed hundreds of people.

Dr. Ingeborg Menzler-Hokkanen suggests that the model, on which NOVA is based, is an excellent example for cooperation. For example, self-financing, course evaluation and feedback, the secretariat structure, etc.

The NOVA Board discussed whether NOVA should enter into cooperation like suggested by the entomology network at HU-AF.



# **Resolution:**

- 1. The Board thinks that it is positive to help in crises. The NOVA Secretariat will help with information regarding the organisation of NOVA and can participate in a skype meeting. NOVA will not offer any economic funding.
- 2. Information that is put together to be presented for the UNHAS must be recorded so that NOVA can use it for similar questions in the future.
- 3. The University of Helsiki is responsible for following up on the matter, including putting together information provided by NOVA and sending a copy of this to the NOVA Secretariat.
