82.1 Approval of the agenda and of minutes of board meeting 81

Resolution:

82.2 Orientation issues

1. Result of per capsulam meeting February 2019

The resolution of the NOVA Board's per capsulam meeting in February 2019 was as follows:



The Board approved that the course "Equitation Science" (SLU) is changed from a master's to a PhD course. The course will receive the same amount of funding as the master's course was accorded in board meeting 81 (decision 81.5.1.12):

- a total lump sum of €10,000, which is a flat rate, plus €1,000 to cover administration, and
- an incentive grant of €2,000 for Nordic cooperation. The final report after completion of the approved NOVA course must confirm that teachers employed at Nordic higher education institutions from at least four different Nordic countries taught the course.

Resolution:

The Board noted the information.

2. NOVA board meeting 83, June 2019

According to the NOVA Strategy for 2018-2021, there should be a NOVA strategy seminar each year. However, AU-ST has informed the NOVA Secretariat that they cannot organise the scheduled seminar for 2019. The NOVA Strategy Seiminar 2019 is therefore cancelled.

There will be a physical board meeting on Monday 3 June 2019. NOVA's future will be discussed. The participants at the meeting will be the NOVA board members and the NOVA Secretariat.

The Secretariat proposed to organize the meeting from 1 pm - 4 pm at a hotel close to Oslo Airport Gardermoen. The meeting will start with lunch at the hotel from 12 noon.

AU-ST apologised for not arranging the strategy seminar. This is due to a reorganisation of the Faculty where the Faculty will be split up in two. This is very time consuming.

In the NSB's opinion, not organising the strategy seminar is a loss of opportunity for the NSB members to meet. The NSB has a big turnover this year which might influence their work in NOVA.

The budget for 2019 may be revised at board meeting 83 (Jun. 2019) to take into account possible adjustments in the activity level. The first half of the member fee for 2019 will be collected in May 2019.

There will be 100% member fee in 2019.

82.4 NOVA annual report 2018

The report shows that there was a reduction in the number of PhD courses and NOVA students on PhD courses in 2018. However, with 13 organised PhD courses, NOVA was very close to reach the goal of running more than 13 PhD courses, which was the average number of courses held in the previous strategic period (2014-2017). It t is positive that the number of PhD courses scheduled for 2019 is increasing compared to 2018. The Network's main tasks in 2018 have been continued simplification and streamlining of the work, as well as implementation and communication of a new NOVA Strategy (2018-2021), and the two-year pilot for a simplified funding model for PhD and master's courses. In 2019, the NOVA Board must decide upon a new NOVA Chair and host of the NOVA Secretariat for the coming period 2020-2022, as NMBU's two terms are ending in 2019. It will also be important to assure that NOVA has the financial resources to meet the ambitions in the Strategy.

- *The course is part of the series Climate change entomology in the North:
- Course 3 (2019) was granted funding of maximum EUR 19 556 plus an incentive grant to be used on administration of EUR 2 500. The NOVA funding of the course will be dependent on the student evaluations of previous courses within the series, as well as the yearly NOVA course budget.
- **The course is part of the series Environmental collaboration and conflict resolution:
- Course 4 (2019) was granted funding of maximum EUR 21 883 plus an incentive grant to be used on administration of EUR 2 500. The funding of a one-day's excursion, which is included in the maximum grant, is conditioned that the excursion takes place in the five-day's on-site course. The course title is changed to Explorations of Collaborative Closures in Environmental Conflicts. The course is granted an exemption from the NOVA course fee. This is a one-time exemption.
- ***The course is part of the course series Plant pathology with a Nordic dimension:
- Course 3 (2019) was granted funding of maximum EUR 17 122 plus an incentive grant to be used on administration of EUR 2 500.
- ****The course is part of the series Phenotyping technologies in plant-environment interactions:
- Course 2 (2019) was granted funding of maximum EUR 14 156 plus an incentive grant to be used on administration of EUR 2 500.
- *****The course is part of the course series Ecostacking: a new approach to crop protection. The course is granted the following funding:
- a total lump sum of €10,000, which is a flat rate, plus €1,000 to cover administration, and
- an incentive grant of €2,000 for course in field prioritised by the NOVA Board in the Open Call 2018.

82.6 Rotating secretariat - next chair

NMBU's period as chair of NOVA and host of the NOVA secretariat will end on 31 December 2019. NMBU will then have hosted the NOVA secretariat for the two last periods: i.e. from 2014 to 2016, and from 2017 to 2019. Discussions concerning the future host of the NOVA secretariat for 2020-2022 were initiated for board meeting 81 (29 November 2018).

The board members presented their thoughts on issues regarding NOVA's future and some ideas for alternative oranisation of the NOVA Network.

Resolution:

- 1. The decision on the host of the NOVA secretariat for 2020-2022 was postponed.
- 2. NOVA's future will be discussed at board meeting 83. The Secretariat was asked to look into if it is possible to finance any activities with the remaning funds in NOVA.

82.7 Prize for best NOVA course 2018

At board meeting 80, the NOVA Board wished to relaunch the prize for best NOVA course to encourage course quality.

The three courses that received the best student evaluations in 2018 were presented to the Board:

- Dog breeding and genetics (master's course), course leader: Odd Vangen (NMBU)
- Questionnaire design and management (PhD course), course leader: Ulf Emanuelson (SLU)
- Biotrophy in plant pathogens from recognition to ecology (PhD course), course leader: Mogens
 Støvring Hovmøller (AU-ST)



Resolution:

The Board asked the Secretariat to send a diploma to the organiser of each of the three courses listed above to acknowledge the excellent courses they have arranged with their course team. This was decided instead of awarding a prize, which is problematic to accept in some contries due to tax rules.

82.8 News from the member institutions

AU-ST

The Faculty will be split in two, which will be very time consuming in the time to come. It might have a positive effect in the long run. The NOVA Chair thanked previous substitute board member Jakob Sehested for his work on the NOVA Board.

UEF-F

No major changes are taking place.

HU-V

In April, there will be a parliamentary election in Finland. Currently the politicians are in favour of increased funding of higher education, but that might change by the end of the year. The University is celebrating its 379th anniversary on 30 March 2019.

LBHI

A new hired rector is starting in 2019 and a new dean began in December 2018. That brings a lot of new energy into the University. The financial situation is quite stable now, so new staff can be hired. The institution will probably have more PhD students in the future. A new joint master's programme is being created in cooperation with HU, AU, Lund University and other institutions.

SLU

The University will have a new vice-chancellor as from June/July coming from Chalmers. She will start the process on a new Strategy that will be valid from 2021. In addition, SLU has ambitions to double the number of students from 2017 to 2027.

NSB

The NSB is currently revising the NSB's statutes, as it has not been done for many years. There has been a large turnover in the group. Recently, they welcomed two new members in the group from NMBU and AU-ST respectively.

NMBU

Norway's adherence to Plan S has created great debate. Plan S points to the obvious vision: Open science to the best of society. Both the facilitation and the time frame that is set up in Plan S have created resistance. Economics and researchers' right to choose the publication channel themselves have been among the topics in the debate. An open-access road map will be created.



Within a couple of weeks NMBU will know the number of applications for its study programmes for 2019.

82.9 Other issues
