

There was a discussion concerning the application for course 4 at the meeting. Björn Thorsteinsson did not understand that he had agreed to be a head applicant for the course. The Board did not approve the application for the course.

The Board's comments to future application processes:

- The Board emphasizes that for future calls only complete applications and budgets will be accepted.
- The Board wishes to receive one table where all applications are summed up, including the amount of EUR applied for.
- The application process needs to be simplified and communicated loudly to all members/local coordinators and on the web.
- The form *Official Approval by Home Institution* can be signed by a Dean, a Vice-Dean or a Head of Department.

The Board approved the budget for 2015 which is presented in the column "Budget 2015" in the chart on the next page. The Board wished to maintain the member fee at the budget level of 2014, which was EUR 355 000. The budget also includes funding of a half time secretary position by EUR 35 500. EUR 35 500 are given as project money for creating a new application platform and improved web pages. The budget for 2015 will be revised in the autumn of 2015.

# **Resolution:**

The Board is willing to appoint an academic representative of the Nordic agricultural universities as a member to the steering committee of Public Private Partnership for pre-breeding for the period 2015-2017.

The Board gave the secretariat a mandate to work on the nomination.

#### 68.6 News from the member institutions

#### **KU-SCIENCE**

Denmark is implementing a new study reform. The aim is that the students finish their studies earlier. They should be full-time students, not part time students. In future, the Danish universities should be accredited, not only the study programmes.

#### **AU-ST**

AU's new rector is Brian Bech Nielsen. As he is the previous dean of AU-ST, there is a new dean at the faculty. After mergers in the last years and centralisation, more administration is now carried out at department level.

#### **LBHI**

The former rector has left and Björn Thorsteinsson is now serving as rector until the possible merger with the University of Iceland or a new rector is elected. The planned merger has halted due to political reasons. LBHI is still experiencing some financial struggles and must reduce the number of employees.

#### **KU-HEALTH**

The veterinary education has been accredited by the European Association of the Establishments for Veterinary Education (EAEVE) earlier. The next step is an accreditation by the American Veterinary Medical Association (AVMA), which will visit KU-HEALTH in April 2015.

#### HU-V

The University of Helsinki has reorganised its PhD education. There are now four doctoral schools. HU-V is involved in two doctoral programmes: Doctoral Programme in Clinical Veterinary Medicine and Doctoral Programme in Food Chain and Health. The university's quality control system was audited in 2014.

#### **UEF-F**

The UEF Doctoral School has 28 doctoral programmes in total. At UEF-F, the studies have become more selective as the number of credits reserved for courses has been reduced.

#### **HU-AF**

HU-AF will in the beginning of 2015 merge with the Ruralia Institute, an independent department under the University of Helsinki.

#### **NSB**

NSB has experienced a reform reducing the number of board members, omitting master's students. NSB held a board meeting on Skype this spring and will hold a meeting at NMBU on September 19-21.



#### **NMBU**

The veterinary education was reaccredited by EAEVE in 2014. The government has announced that there will be changes in the structure and contents of higher education in Norway. It has challenged the higher education institutions to explore possibilities for new structures.

# A. Follow-up on the Strategic seminar September 18, 2014

The Board decided the following:

- a. A taskforce among the Board members will be set down to investigate on external funding, e.g. from the Nordic council of Ministers (NCM). Grete Bertelsen, Elise Norberg and Hans Henrik Dietz are responsible for writing a draft mandate for next board meeting.
- b. The board expects a new attractive web site to be up and running by the end of 2015.

The Board also discussed the issues below. The Board asked the secretariat to prepare suggestions for the issues which should be put forward to the Board at next board meeting:

- Proposal for a new system of coverage of administrative expenses for PhD courses
- Financial treatment of student participation fees from fee-paying students
- Duration of the open call 2015 and frequency of decision-making on the applications
- Proposal from Hans Henrik Dietz, submitted to the secretariat on September 19, on a general text about NOVA to be presented on the member institutions' websites:

"NOVA is a Nordic university cooperation aimed at supporting understanding of the major global challenges in a Nordic context. Our main task is to initiate, administer, promote and financially support cooperation between the Nordic universities in postgraduate education.

We want to enhance a more global adoption of good practises within the Nordic countries. We provide a platform for networking between Nordic post graduate students through facilitating high quality, international level education for post graduate students.
