The grant can not by any means be used to cover teachers travel expenses to Ethiopia, nor students travel expenses.

The grant has therefore been reduced with 8 000 Euro.

The amount asked for to hire a course secretary (3 380 Euro) is also reduced from the total grant; costs for administration up to 10 % are already included in the grant.

#### Remark:

The Nordic dimension, which is a characteristic for Nova PhD courses, is in this application missing: Only one Nova teachers is involved in the teaching – the involvement of the rest of the course team is unclear. There is no contribution from the Nordic course group in the teaching activities.

The course plan is unrealistic; 150 student hours during the course are allocated for 10 days, which implies 15 hours of work per day.

The network must consider involving network partners from the not represented Nova members.

Marketta did not participate in the decision concerning applications no. 9 and 15. Aija did not participate on the decision on application no. 15.

The following decisions on PhD funding in general were taken:

- Travel support to Nova teachers can only be used for travel within the Nova/Bovaregion i.e. between the Nordic and the Baltic countries
- The application assessment will for the future be stricter on that correct CV format (max 4 pages) is used.
- The function Course Leader shall in future applications be replaced by Academic Course Leader and CV will be required. The function Head Applicant remains but no CV will be required.
- A second call for PhD courses 2010 with deadline 15 October, 2009 shall be announced.

### 31.5 Other applications

#### Decision:

The decision on these applications was delegated to Nova EC. All applications concern amounts less or equal 5 000 Euro.

The decision is attached to the minutes.

### 31.6 Funding scheme for summer courses 2010

#### Decision:

The course and grant conditions for Nova summer courses 2010 were decided to as follows (changes from suggestion were made):

#### Course conditions

- The course shall run in collaboration between at least two Nova members from two different countries.
- The course shall run during the summer. The exact timing for "summer" shall be defined together with the local coordinators in order to find the optimal time period.
- The course must be open for BSc students, preferably should first year students be able to take the course.
- Courses that include field visits and exercises are favoured in the evaluation.
- Course topics that are of interest to many first year students within Life Sciences are favoured in the evaluation.

#### Grant conditions

The course can get a maximum support of 5 000 Euro. The grant can cover the following costs (*same as for intensive courses on MSc level*):

- Remuneration to invited non-Nova teachers. The use of external teacher must be motivated in the application.
- Miscellaneous (material, transports, rents, social events).
- Administration max 10% of the total grant. Does not have to be specified.
- On off-campus courses, costs for student accommodation can partly be covered in order to not having to separate students from the host member (the member giving the course) and the incoming students, where the latter group can receive a Nordplus grant for accommodation, while the former cannot.

A discussion on NIMC grants and housing was held below item 31.8

# 31.7 Follow-up on activities including new areas

Sum-up of information on activities on the local member institutions given by the local coordinators:

Guri (UMB) informed that there has been an increasing awareness of Nova after the seminar in April, that information on Nova is given to all new PhD students, and that meetings with head of departments are held. The local Nova web page is improved. A new prospective area is Biotechnology – a meeting with representatives will be held after the summer.

Elise (AU-DJF) reported from their first local team meeting, which treated how to promote Nova and concluded that the best way is by talking directly to teachers and students. AU-DJF will possibly hand in PhD course applications to the October call.

Melaine (NVH) explained that Nova and Nordplus information on NVH is disseminated by being included in the weekly email from the management. There is an interest to take part in the proposed Animal Welfare network. The MSc course in ophthalmology will not be given next year.

Stina-Lena (SLU) reported on the local discussions on new areas. There is an interest in revitalizing the network in Forest Production and Soils. A possible new area that has been identified is Green Therapy. SLU would like to have names of possible network members. A seminar for student "Studies abroad – a key to good jobs" has been held at SLU.

Aija (JU-F) informed that possibly new networks in Forest Technology and Bioenergy/ Forest Based Bio Energy will be initiated. Due to the intensive merging activities on JU-F few applications to PhD courses has been handed in. The seminar gave good response at JU-F from students and other participants.

Janna (HU-V) reported on the interest on a network in Animal Welfare and in Reproduction. A Nova blog has been set up and there is a good cooperation with the students.

Jill (LIFE) reported that Nova intensive courses have been promoted as well as study abroad for PhD students. NorPath is striving to become a double degree programme. The Food of Life application to Erasmus Mundus has been submitted (Nova supported). New networks of interest in Animal Welfare, Green Therapy, and Food Culture

Björn (LBHI) reported that there is an interest in a network in Grazing Ecology.

Sari (HU-V) informed that the Nova activities have included feed back on the seminar which will be used in the new 3-year plan for studies. A request on new areas around the institutions resulted in little response. A new MSc programme in English will be launched: "Environment and Natural Resources". Food Safety is suggested as a new network area.

#### Ulf (Nova) reported that:

- The three Nova supported Erasmus Mundus applications have been submitted, and a summary of them was distributed.
- Progress on new web is slow due to lack of time. Quicker progress is expected during the summer.
- Ulf will go on paternity leave 13 August; a new secretary will be hired to SLU, starting 1 August.
- A new PhD network in Forage Maize is being formed.

# 31.8 Follow-up on seminar 2009

### Decisions

Long term funding for NIMC:

Nova shall construct a grant scheme that gives applicants the possibility to apply for a NIMC grant for three consecutive years. This shall apply to both when same course is planned to be given all three years and when a series of three courses is planned. Each year the course is followed up by submission of student and teacher evaluation and support can based on these be discontinued. The grant sum is max 5 000 Euro per course and year. The secretariat is responsible for the implementation and announcement of this grant scheme.

## NIMC and housing:

The issue was postponed to the next meeting in order for NSB to have time to discuss the question and provide input to KUF.

Teachers' marketing of international studies:

The item was sent to the local teams for discussion and will be brought up on next KUF meeting.

Administrative issues, workshop:

#### **31.9 Nova seminar 2010**

#### Decisions:

- Nova seminar 2010 will be held on Iceland. Date suggestions will be discussed between secretariat and LBHI.
- The topic of the seminar will be the new strategy for Nova 2011-2014. The seminar should be used as an outlook on international movements and trends relevant for the strategy.

# 31.10 Bova seminar "Development and..."

A short discussion on the content and possible seminar participants was held. Secretariat has sent directed invitations to Nova teachers with involvement in the Baltic.

The seminar will be an opportunity for Nova administrators to discuss the routines on joint courses.

#### Decisions:

- Nova allocates 2 500 Euro to support 50 % of the travel costs for Nova participants.

#### 31.11 Other issues

One other issue regarding evaluations in decision making raised by Meri (NSB) was postponed due to time constraints.
